

Campaign Compass End-User License Agreement

Last Updated: March 12, 2026

This End-User License Agreement ("Agreement") is a legal agreement between you and **Mind Forge Studio** for the use of **Campaign Compass** and any related files, downloads, updates, documentation, and services provided with it (collectively, the "Software").

By purchasing, downloading, installing, activating, accessing, or using the Software, you agree to be bound by this Agreement. If you do not agree, do not purchase, download, install, activate, access, or use the Software.

1. License Grant

Mind Forge Studio grants you a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to install and use Campaign Compass for your own internal business or personal use, subject to this Agreement.

This is a license to use the Software only. You are purchasing usage rights, **not ownership** of the Software or any intellectual property rights in it.

2. Ownership

Campaign Compass is licensed, not sold. The Software, including its code, structure, design, features, interface, branding, documentation, and all related intellectual property rights, is and remains the exclusive property of Mind Forge Studio and its licensors.

Except for the limited license expressly granted in this Agreement, no right, title, or interest in the Software is transferred to you.

3. Permitted Use

You may use Campaign Compass only as authorized by Mind Forge Studio and only in compliance with this Agreement and all applicable laws.

You may:

- install and use the Software for your own authorized use;
- use the Software in connection with your own business, author, publishing, or promotional workflow;
- retain copies reasonably necessary for backup or reinstall purposes, subject to your valid license.

4. License Restrictions

You may not, and may not permit any third party to:

- copy, reproduce, distribute, publish, or share the Software except as expressly allowed by this Agreement;
- sell, resell, rent, lease, sublicense, assign, transfer, or otherwise make the Software available to any third party;
- modify, adapt, translate, alter, or create derivative works of the Software;
- reverse engineer, decompile, disassemble, decode, or otherwise attempt to discover the source code, underlying ideas, algorithms, or structure of the Software, except to the limited extent such restriction is prohibited by applicable law;
- remove, alter, obscure, or bypass any copyright, trademark, license key, activation, security, or proprietary notice or protection mechanism;
- use the Software in any way intended to circumvent licensing controls, device limits, account protections, or usage restrictions;
- use the Software to provide timesharing, service bureau, hosted access, white-label access, or similar services for third parties unless expressly authorized in writing by Mind Forge Studio;
- use the Software for unlawful, infringing, deceptive, abusive, or unauthorized purposes;
- use the Software in a way that interferes with, disrupts, or damages the Software, related systems, or third-party services.

5. License Keys, Activation, and Device Limits

Use of Campaign Compass may require a valid license key, activation, account verification, device registration, or similar access controls.

Your license is subject to the activation, device, account, or usage limits established by Mind Forge Studio for the version of the Software you purchased. You may not bypass or attempt to bypass those limits.

Mind Forge Studio may suspend, restrict, or revoke access to the Software if it reasonably believes a license key, activation, or account has been shared, transferred, abused, obtained fraudulently, or used in violation of this Agreement.

6. Updates and Changes

Mind Forge Studio may provide patches, updates, fixes, enhancements, or new versions of the Software at its discretion. Unless stated otherwise, those updates are governed by this Agreement.

Purchase of the Software does not guarantee any particular future update, feature, release schedule, compatibility commitment, or continued availability of any version.

Mind Forge Studio may modify, improve, replace, discontinue, or limit features of the Software at any time, subject to applicable law.

7. Third-Party Services and Data Sources

Campaign Compass may interact with or depend on third-party platforms, services, websites, APIs, data, accounts, or content. Mind Forge Studio does not own or control those third-party services.

Your use of third-party services remains subject to the terms, policies, permissions, and restrictions of those third parties. You are responsible for ensuring your own use complies with any applicable third-party requirements.

Mind Forge Studio is not responsible for third-party outages, policy changes, access restrictions, removed features, data errors, discontinued services, or any loss resulting from third-party systems or content.

8. User Responsibility

You are responsible for:

- maintaining the confidentiality of your license key and account credentials;
- ensuring your device and environment are compatible with the Software;
- reviewing and verifying information, imported data, synced data, reports, or outputs before relying on them;
- maintaining your own records, backups, and operational safeguards as appropriate for your use.

9. Documentation and Support

Any documentation, guides, help materials, or support provided by Mind Forge Studio are provided for general informational purposes only and do not create any warranty, guarantee, or separate contractual obligation unless expressly stated in writing.

10. Termination

This Agreement remains in effect until terminated.

It will terminate automatically if you fail to comply with this Agreement. Mind Forge Studio may also suspend or terminate this Agreement or your access to the Software if it reasonably believes you have violated this Agreement or used the Software in a prohibited manner.

Upon termination, you must stop using the Software and delete or destroy all copies in your possession or control, except to the extent you are required by law to retain them.

11. Refunds

Refund eligibility, if any, is governed by the applicable Mind Forge Studio refund policy or any separate written terms presented at the time of purchase.
